The purpose of this application is to allow the diversion of the footpath to allow construction of new buildings as permitted under DC/19/3497/FUL and provide a better defined, safer, and no less convenient footpath route through Clopton Commercial Park which will give formal recognition to the route on the ground and provide greater separation between pedestrians and site vehicle traffic. The proposed line of the diverted footpath will run alongside existing site roadways which provide access to both sides of the workshop, warehouse and office buildings of Clopton Commercial Park which occupy a 350m length of the former airfield runway.
